INTRODUCTION

For the past twenty years, the Maryland Commission for Women has conducted a comprehensive review and analysis of selected U.S. Census data as a tool for determining the current status of women and girls in Maryland. By tracking the trends affecting women and girls, the Commission is better able to engage in its strategic planning efforts to address the needs of the state's female population. The Commission's role of advising government is greatly enhanced when we are armed with the facts about women's lives, and not just anecdotal evidence. We have seen tremendous progress over the past twenty years, both in terms of women's status and in terms of public access to census data via the Internet.

The purpose of this report is to digest the reams of data available from the census so that the citizens of Maryland can have access to a user-friendly analysis of what is happening to the women and girls of our state. As with any digest, some items were excluded. Those seeking additional data on the status of women should refer to the *Research Notes* section of this report for further guidance.

Throughout the report, we have attempted to compare data from the past two decennial censuses (1990 and 2000). Data is for the year 2000, unless otherwise stated. Unfortunately, the same data are not always collected or reported each decade by the Census Bureau. This lack of data is especially true for certain racial and ethnic subcategories of the population. The racial and ethnic categories for the 1990 and 2000 Census's are not the same. With the growing diversity of this nation, the old 1977 standards are not representative of the U.S. population in 2000. Categories have been added or changed. For example, the Native Hawaiian or Pacific Islander category was added and separated out from the Asian category. Therefore, we could not accurately compare the 1990 and 2000 Asian category. According to the Office of Budget and Management, "The revised standards will have five minimum categories for data on race: American Indian or Alaska Native, Asian, Black or African American, Native Hawaiian or Other Pacific Islander, and White. There will be two categories for data on ethnicity: 'Hispanic or Latino' and 'Not Hispanic or Latino'." (See second hyperlink below) There were also new categories, such as "Some Other Race Alone" and individuals of "Two or More Races". Because they were new, there was no corresponding variable for 1990. In this report, we used the "Some Other Race Alone" category for some data, but not the "Two or More Races" category. For the Hispanic or Latino category, we focused on the total number of individuals who identified themselves as Hispanic or Latino. If data is missing or represented by a *, it is because it was not available. Finally, because this report is a digest, and not a complete reporting of the data, some readers may not find the level of detail they desire. Again, a visit to the State Data Center web site should be helpful in ascertaining additional data.

EXECUTIVE SUMMARY

The State of Maryland has experienced significant demographic change during the last decade, with women making significant strides in some areas, while seeing a lack of progress in others. The state's female population is older, more racially and ethnically diverse, better-educated, and earning more money than it was 10 years ago. However, women's progress in Maryland has not always kept pace with men's, and there are significant disparities among different groups of women in terms of key economic indicators. These disparities may also be observed across geographic lines, with some Maryland jurisdictions making greater progress than others in improving the status of women. In this Executive Summary, we provide major highlights of significant trends.


Between 1990 and 2000

Population

• The total female population increased by 8 percent, from 2.5 million to 2.7 million.

Race/Ethnicity

- White (non-Hispanic) women comprise 63 percent of the female population, a decrease from 70 percent in 1990.
- African American women comprise 29 percent of the female population, an increase from 26 percent in 1990.
- Asian women comprise four percent of the female population (an increase from three percent in 1990), as do Hispanic women (also an increase from three percent in 1990).
- American Indian, Alaska Native, Hawaiian and Pacific Islander women comprise less than one percent of the female population (data was not reported in 1990).
- Disparities among jurisdictions are significant: 96 percent of the female population in Allegany County is white, compared with just 31 percent of the Baltimore City female population. In




Allegany County, a mere 2 percent of the female population is African American, compared with 65 percent in Baltimore City.

Age

- The median age of the female population in 2000 was 37, compared with 34 in 1990.
- The percentage of women over age 65 remained relatively stable, comprising approximately 13 percent of the total female population.

- Among women over 65 years of age, non-Hispanic whites constitute 78 percent of the population (versus 63 percent of all women in 1990), while African American women constitute 19 percent (versus 29 percent of all women in 1990).
- Approximately 24 percent of the female population were 18 years old or younger in 2000, which is about the same as in 1990.




Among girls under 18 years of age, non-Hispanic whites constitute 58 percent of the female population (versus 63 percent of all women in 1990), while African American girls constitute 32 percent (versus 29 percent of all women in 1990).

Marriage and Childbearing Patterns¹

• The percentage of women who are currently married has increased slightly, from 50 percent to 53 percent, as has the percentage that were previously married, from 24 percent to 26 percent. The percentage of women who have never been married

increased slightly from 26 percent in 1990 to 27 percent in 2000.

- The percentage of mothers who are under 18 years of age decreased by less than one percent, from 3.9 in 1990 to 3.6 percent in 2000.
- The percentage of mothers who are over 35 years-of-age increased by eight percent, from 10 percent to 18 percent.
- Disparities among jurisdictions are significant: in Baltimore City, 41 percent of the female population has never been married, compared with 17 percent in Queen Anne's County. Almost ten percent of all teenage girls (<18) in Baltimore City are mothers, compared with just one percent in Howard County.



Family/Household Formation¹

- In 2000, family households made up 69 percent (71 % in 1990) of all households, leaving 31 percent (29% in 1990) as non-family households. Of these non-family households, 25 percent (23% in 1990) were living alone and 6 percent (same as in 1990) were not.
- In 2000, female-headed households, with no husband present, made up 14 percent (13 percent in 1990) of all households and male-headed households, with no wife present

- made up only 4 percent. Female-headed households (no husband present) outnumber male-headed households (no wife present) by nearly four to one.
- As a proportion of all families with children under age 18, female-headed households comprise 22 percent (19 percent in 1990), while male-headed households comprise 5 percent, in 2000.

Education

- The percentage of women over the age of 25 who have graduated from college increased from 23 percent to 36 percent, while the percentage of those with less than a high-school education decreased from 22 percent to 16 percent.
- Men still slightly outpace women when it comes to earning college degrees, while the high school dropout rate among men and women is comparable.
- There are troubling racial disparities among women, for example, close to 35 percent of all Hispanic women over the age of 25 have not completed high-school, compared with 14 percent of non-Hispanic white females and 20 percent of African-American females.
- Disparities among jurisdictions are significant: 31 percent of all females in Baltimore City lack a high-school diploma, while that number is just 7 percent in Howard County.

Employment/Earnings

- The percentage of women in the labor force remained constant, at 63 percent. However, the labor force participation rate for Hispanic women declined by eight percentage points, from 71 percent to 63 percent.
- In 2000, 43.3% of females worked in Management, Professional and Related occupations, as compared to men at 39.3%. In Sales and Office occupations, the proportion was 35.8% female and 17.4% male.
- Annual median earnings for women working full-time are just 71 percent of those earned by men, a figure that remained constant between 1990 and 2000. Women earn \$24,735 (up from \$22,000 in 1990), while for men the figure is \$34,682 (up from \$31,000 in 1990).
- Disparities among jurisdictions are significant: In Allegany County, 50 percent of the female population is in the labor force, compared with 69 percent in Howard. Median earnings for women in Somerset County are just \$12,986, compared with \$30,636 in Howard County.

Poverty

- Nine percent of the female population lives in poverty, with 11 percent of all girls (<18) living in poverty, and 10 percent of elderly women (>65) living in poverty.
- The percentage of female-headed family households living in poverty declined from 21 percent in 1990 to 18 percent in 2000. However, this is still double the poverty rate of male-headed family households (nine percent).
- Among female-headed family households, there are significant racial disparities. Twenty-two percent of African Americans in this category are living in poverty, while just 13 percent of White (Non-Hispanic) women in this category live below the poverty line.

Disparities among jurisdictions are significant: in Somerset County, 22 percent of the female population lives in poverty, while in Howard and Carroll counties that number is just four percent. In Baltimore City, 32 percent of all female-headed family households live in poverty, compared with just ten percent in Howard County. Also in Baltimore City, an alarming 24 percent of females live in poverty, with 32 percent of them under the age of 18 and 21 percent of them over the age of 65.

National Rankings of Interest

According to the 2002 Institute for Women's Policy Research Fact Sheet on The Status of Women in Maryland:

- Maryland women rank second in the nation in annual median earnings (1999), ninth in ratio of women's earnings to men's earnings (1999), fourteenth in women's labor force participation (2000), and second in the percentage of women in managerial and professional occupations.
- Maryland women rank sixth in educational attainment, concerning the percentage of women with four or more years of college (1990).
- Maryland women rank eighth in the percentage of women above the poverty level (1999).

I. Demographic Overview

In 2000, there were 37,699 females in Allegany County, making up 50.3% of the population, a decrease from 39,672 or 52.9% females in 1990. White females made up 96.0% of the population in 2000, a slight decrease from 97.6% in 1990. African American females made up 2.2% of the population in 2000, an increase from 1.8% in 1990. The population of American Indian/Alaskan Native, Asian, and Hispanic females in 2000 was 0.1%, 0.7%, and 0.7%, respectively. The median age for all females was 41.5.

II. Women's Marriage and Childbearing Patterns

In 2000, 54.6% of females over the age of 25 were married, an increase from 51.5% in 1990. In 1990 and 2000, 21.2% of females had never been married. In 2000, 30.1% of females had been previously married (spouse absent), an increase from 27.3% in 1990. The number of Allegany County females giving birth in 2000 was 794, a decrease from 904 in 1990. In 2000, the percentage of females giving birth, who were under 18 was 4.4%. The proportion of females giving birth, who were ages 18-34 was 86.7%. The proportion of females giving birth, who were over the age of 35 was 8.9%.

III. Women and Education

In 2000, the proportion of females, 25 years of age or older, without a high school diploma was 20.6% as compared to males at 19.6%. In 2000, 16.9% of females had attended college as compared to males at 16.1%. Females were graduating from college at a greater rate of 22.2%, as compared to males at 19.7%.

The proportion of females over the age of 25 without a high school diploma decreased from 29.6% in 1990 to 20.6% in 2000. In 2000, 20.4% of White females did not have a high school diploma; a decrease from 29.7% in 1990. In 2000, 30.2% of African American females did not have a high school diploma an increase from 27.4% in 1990. The percentages for Hispanic, Asian, and American Indian/Alaskan Native females were 20.8%, 25.5%, and 44.2%, respectively.

In 2000, 22.2% of females over the age of 25 were college graduates, an increase from 10.0% in 1990. Among White females in 2000, 7.1% had a Bachelor's degree. Among African American females in 2000, 4.2% had a Bachelor's degree. The percentages for Hispanic and Asian females were 25.5% and 45.4%, respectively.

In 2000, the proportion of females over the age of 16 in the labor force was 15,476 or 49.7%, an increase from 44.9% of females in 1990. The proportion of males age 16 and older in the labor force was 17,520 or 57.5%. The percentage of females with children under age 6 in the labor force in 2000 was 65.0%, an increase from 57.1% in 1990. The percentage of White females over the age of 16 in the labor force in 2000 was 49.4%. The percentage of African American females over the age of 16 in the labor force in 2000 was 59.6%. The percentages for Asian and Hispanic females were 50.5% and 70.0%, respectively.

In Allegany County, in 2000, there were 14,117 civilian (non-military) working females and 15,914 civilian (non-military) working males. Of those people, 32.4% of females worked in Management, Professional and Related occupations, as compared to men at 22.4%. In Service occupations, the proportion was 22.4% female and 16.3% male. In Sales and Office occupations, the proportion was 37.6% female and 15.0% male.

Median Earnings for FY 1999

In Allegany County, in 1999, the median earnings for males were \$23,846 and \$13,926 for females. White males made \$31,385, while White females made \$21,355. African American males made \$26,250, while African American females made \$19,635. Hispanic males made \$26,607, while Hispanic females made \$19,028.

V. Women as Family Heads

In Allegany County in 2000, females, with no husband present, made up 2,747 householders out of the 29,350 total households, or 9.4%. The number of female householders with their own children under 18 was 1,480, or 5.0%. Male householders with no wife present made up 3.5% of all householders.

VI. Women in Poverty

In Allegany County in 2000, the proportion of females living in poverty was 16.2%, with girls under the age of 18 constituting 19.0% of all female poverty and women over age 65 constituting 11.7% of all female poverty. In 2000, 945 householders with no spouse present were living below the poverty level. In 2000, 155 or 15.0% of male householders with no wife present were living below the poverty level as compared to 790 or 28.8% of female householders with no husband present. Among White male and female householders with no spouse present, 14.3% and 28.9% were below poverty level, respectively. Among African American male and female householders with no spouse present, 0.0% and 19.8% were below poverty level, respectively.

VII. Women Over Age 65

In Allegany County, females over the age of 65 made up 21.7% of the female population in 1990 and 21.5% in 2000. Of the population in 2000, 98.6% were White, 1.1% was African American, 0.1% was Hispanic, and 0.1% was Asian.

VIII. Women Under Age 18

In Allegany County in 2000, females under age 18 made up 19.9% of the female population. Of that population, 93.7% were White, 2.6% were African American, 1.0% were Hispanic, 1.4% were Asian, and 0.3% were of another race.

I. Demographic Overview

In 2000, there were 245,430 females in Anne Arundel County, making up 50.1% of the population, an increase from 212,157 or 49.7% females in 1990. White females made up 81.4% of the female population in 2000, a decrease from 85.6% in 1990. African American females made up 13.2% of the population in 2000, an increase from 11.7% in 1990. The population of American Indian/Alaskan Native, Native Hawaiian/Other Pacific Islander, Asian, and Hispanic females in 2000 was 0.3%, 0.04%, 2.5%, and 2.6%, respectively. The median age for females was 36.9.

II. Women's Marriage and Childbearing Patterns

In 2000, 59.0% of females over the age of 25 were married, an increase from 57.5% in 1990. In 2000, 21.6% of females had never been married, a slight increase from 21.4% in 1990. In 2000, 24.2% of females had been previously married (spouse absent). In 1990, 21.1% were previously married. 6,790 Anne Arundel County females gave birth in 2000, a slight increase from 6,778 in 1990. In 2000, the percentage of females giving birth, who were under 18 was 2.6%. The proportion of females giving birth, who were ages 18-34 was 79.7%. The proportion of females giving birth, who were over the age of 35 was 17.7%.

III. Women and Education

In 2000, the proportion of females, 25 years of age or older, without a high school diploma was 13.5%. For males, it was 13.6%. 22.7% of females had attended college as compared to males at 21.0%. Females were also graduating from college at a rate of 34.8% slightly lower than males at 38.7%.

In 2000, 12.4% of White females over the age of 25 did not have a high school diploma, a decrease from 18.0% in 1990. In 2000, 18.8% of African American females did not have a high school diploma, a decrease from 29.0% in 1990. The percentages for Hispanic, Asian, American Indian/Alaskan Native, and Native Hawaiian/Pacific Islander females were 17.0%, 23.1%, 16.4%, and 15.9%, respectively.

In 2000, 34.8% of females over the age of 25 were college graduates, an increase from 20.3% in 1990. Among White females in 2000, 18.7% had a Bachelor's degree. Among African American females in 2000, 14.1% had a Bachelor's degree. The percentages for Hispanic, Asian, American Indian/Alaskan Native, and Native Hawaiian/Pacific Islander females were 16.0%, 21.1%, 21.3%, and 9.5%, respectively.

In 2000, the proportion of females over the age of 16 in the labor force was 125,267 or 65.3% as compared to 65.2% of females in 1990. There were 144,505 or 77.1% of males age 16 and older in the labor force. The percentage of females with children under age 6 in the labor force in 2000 was 70.9%, an increase from 66.5% in 1990. The percentage of White females over the age of 16 in the labor force in 2000 was 64.9%. The percentage of African American females over the age of 16 in the labor force in 2000 was 67.7%. The percentages for American Indian/ Native Alaskan, Asian, Native Hawaiian/Pacific Islander, and Hispanic females were 69.5%, 60.9%, 94.2%, and 68.6%, respectively.

In Anne Arundel County, in 2000, there were 119,040 civilian (non-military) working females and 131,214 civilian (non-military) working males. Of those people, 41.5% of females worked in Management, Professional and Related occupations, as compared to men at 39.5%. In Service occupations, the proportion was 14.5% female and 10.6% male. In Sales and Office occupations, the proportion was 38.9% female and 18.0% male.

Median Earnings for FY 1999

In Anne Arundel County, in 1999, the median earnings for males were \$37,383 and \$25,717 for females. White males made \$46,166, while White females made \$33,335. African American males made \$32,157, while African American females made \$30,438. Hispanic males made \$30,298, while Hispanic females made \$26,823.

V. Women as Family Heads

In Anne Arundel County in 2000, females, with no husband present, made up 19,431 of all householders out of 178,754 total households, or 10.9%. The number of female householders with their own children under 18 was 10,874, or 6.1%. Male householders with no wife present made up 4.1% of all householders.

VI. Women in Poverty

In Anne Arundel County in 2000, the proportion of females living in poverty was 5.9%, with girls under the age of 18 constituting 6.9% of all female poverty and women over age 65 constituting 7.0% of all female poverty. In 2000, 3,057 householders with no spouse present were living below the poverty level. In 2000, 450 or 6.2% of male householders with no wife present were living below the poverty level as compared to 2,607 or 13.4% of female householders with no husband present. Among White male and female householders with no spouse present, 5.4% and 8.2% were below poverty level, respectively. Among African American male and female householders with no spouse present, 10.0% and 24.2% were below poverty level, respectively. Among Hispanic male and female householders with no spouse present, 0.0% and 26.6% were below poverty level.

VII. Women Over Age 65

In Anne Arundel County, females over the age of 65 made up 10.4% of the female population in 1990 and 11.6% in 2000. Of that population in 2000, 87.8% were White, 10.1% were African American, 0.8% were Hispanic, 1.5% were Asian, 0.15% were American Indian/Alaskan Native, and 0.02% were of another race.

VIII. Women Under Age 18

Among them, 7,392 or 9.0% of male householders with no wife present were living below the poverty level; which is half the number of female householders with no husband present at 49,841 or 18.4%. Among White male and female householders with no spouse present, 6.2% and 13.0% were below poverty level, respectively. Among African American male and female householders with no spouse present, 12.9% and 22.2% were below poverty level, respectively. Among Hispanic male and female householders with no spouse present, 9.5% and 23.7% were below poverty level, respectively.

VII. Women Over Age 65

In Maryland, females over the age of 65 made up 12.7% of the female population in 1990, about the same as 12.9% in 2000. Of the population in 2000, 77.7% were White, 18.9% were African American, 1.4% were Hispanic, 2.2% were Asian, 0.15% were American Indian/Alaskan Native, 0.02% were Native Hawaiian/Pacific Islander, and 0.34% were of another race.

VIII. Women Under Age 18

In Maryland in 2000, females under the age of 18 made up 24.1% of the female population. Of that population, 58.0% were White, 32.2% were African American, 5.2% were Hispanic, 3.6% were Asian, 0.26% were American Indian/Alaskan Native, 0.04% were Native Hawaiian/ Pacific Islander, and 2.2% were of another race.
