Dear Providers:

The Office of Licensing and Monitoring is sending this letter to inform providers of the new laws that may impact their program operations. Effective immediately, pursuant to Code of Federal Regulations (CFR) 28.20.33 & 28.50.12, Criminal Procedure Article Section 10-219 (a), Annotated Code of Maryland and Code of Maryland Regulations (COMAR) 12.15.11 only the Criminal Justice Information System (CJIS) Central Repository is allowed to disseminate criminal information for non-criminal justice purposes. Sharing the criminal history results obtained from CJIS Central Repository is a violation of the above federal and state laws and regulations.

Providers are not allowed to share CJIS criminal history on any documents to another entity. If another entity requires the criminal history, they must request the criminal history directly from CJIS Central Repository per CFR 28.50.12(b). "The FBI Director is authorized by 28 CFR 0.85(j) to approve procedures relating to the exchange of identification records. Under this authority, effective September 6, 1990, the FBI Criminal Justice Information Services (CJIS) Division has made all data on identification records available for such purposes. Records obtained under this authority may be used solely for the purpose requested and cannot be disseminated outside the receiving departments, related agencies, or other authorized entities." For example, sending the home study packet with the CJIS background results, employment record etc. to another entity is a violation of the laws mentioned in this letter.

Dear Providers:

The Office of Licensing and Monitoring (OLM) is sending this letter to inform providers that as of February 7, 2014, all childcare agencies have been receiving full disclosure of the FBI clearances. (For the purposes of this letter, the term "full disclosure" means a detailed criminal history report from Clarksburg, WV). Prior to this date, childcare agencies were only being notified that "the covered individual is the subject of criminal charges per the FBI Criminal History Report" and "Federal Public Law 92.544 prohibits the dissemination of information regarding these charges."

OLM is requesting that your agency conduct an internal audit between now and August 1st of all records (i.e. employees, Board of Directors, volunteers and interns) to ensure that ALL FBI clearances include a full disclosure of criminal charge(s). For Treatment Foster Care and Adoption programs, an internal audit of the foster homes, including ALL household members age 18 and over is also required.

Upon review of the individual's FBI clearance, if it documents that "the covered individual is the subject of criminal charges" and does <u>NOT</u> include the full disclosure from Clarksburg WV, then an updated FBI clearance **MUST** be requested.

Please find the attached excel spreadsheet, which is due to OLM by August 15, 2016.

Residential Child Care Program (RCC) reports should be emailed to

OLM.RCCupdates@maryland.gov and Child Placement Agency (CPA) reports should be emailed to OLM.CPAupdates@maryland.gov. This report should include all individuals that are "the subject of criminal charges" and there are missing full disclosure documentation. (Columns A and B must be completed for each individual.)

Once the internal audit is completed and the clearance is found to identify an individual as the subject of criminal charge/charges and there is NO documentation of the Full Disclosure, then the identified individual must complete an updated FBI clearance. This process MUST be completed by September 15, 2016. Once the updated FBI clearances are completed and received, then an updated excel spreadsheet is due to OLM by October 1, 2016 via the above email process. (On the updated spreadsheet, columns C to H must be completed for each individual.)

Please find the attached redacted examples of a clearance with the full disclosure of criminal charge from Clarksburg WV as well as a clearance that "prohibits the dissemination of information regarding these charges." In the latter example, an updated FBI clearance is required.


